What is HFW?

- INTENSIVE national evidence-based model (it's proven to work!)
- Family at the center of the team
- Use family strengths & family voice to develop family-driven plan towards identified family vision
- Supports the entire family in working together to build their strengths and skills
- Builds family up & supports family to self-advocate through coaching and partnership
- Over time, increase empowerment of family as lead & decrease role of HFW Care Manager
- HFW Care Manager as family partner & facilitator of process
- HFW Care Manager supports care team in their role as a resource to the family
- HFW Care Manager assists in building the care team (natural supports, schools, therapists, parent advocates, medical professionals, etc)
- HFW Care Manager gradually supports the family in taking over collaboration and coordination with team

What are eligibility criteria?

- School-aged youth (ages 5-20) residing in Yates County *or* in Dundee or Marcus Whitman Schools
- Diagnosed Serious Emotional Disturbance
- Medicaid eligible *or* non-Medicaid & willingness to be assessed for / enrolled in Medicaid
- Demonstrated willingness to engage in the HFW process (including **monthly** team meetings)
- Involved in behavioral health-oriented services, and/or involved with multiple systems (mental health, child welfare, special education, juvenile justice, addiction services, child health, etc) in the last 6 months
- Has CANS-NY high acuity/needs (HFW Care Manager assesses for this; existing CHHUNY members must be rated high by current Care Manager's assessment)
- Is at risk of higher level of care as shown by one or more of the following:
 - Is at risk of out-of-home care and treatment due to challenges living in the home and community
 - In the past 6 months, was assessed for or was in out-of-home care and treatment due to challenges living in the home and community
 - In the past 6-12 months, had multiple visits with 911, emergency room, mobile crisis / CPEP, emergency respite, Home-Based Crisis Intervention (HBCI)
 - In the past 6 months, had change in childcare, aftercare, or school due to significant behavioral issues related to mental health needs
