

## High Fidelity Wraparound updated 10/11/2024

## What is HFW?

- INTENSIVE national evidence-based model (it's proven to work!) with family at the center of the team
- Uses family strengths & family voice to develop family-driven plan towards identified family vision.
- Builds family strengths and skills & supports family to self-advocate through coaching and partnership
- Over time, increases empowerment of family as lead & decrease role of HFW Care Manager
- HFW Care Manager as family partner & facilitator of process
- HFW Care Manager supports care team in their role as a resource to the family, and builds the team

## What are eligibility criteria?

- School-aged youth (ages 6-21) residing in Chemung, Schuyler, Steuben, or Yates County or attending Dundee or Marcus Whitman Schools
- Health Home enrolled/eligible with Serious Emotional Disturbance (SED) or 2 Mental Health diagnoses
- Has CANS-NY high acuity/needs (HFW Care Manager assesses for this; existing CHHUNY members must be rated high/complex by current Care Manager's assessment)
- Demonstrated willingness to engage in the HFW process (including *monthly* team meetings)
- Involved in two or more systems / services (child welfare, juvenile justice, complex health with ongoing specialized medical care, mental health, substance use, special education, learning/intellectual disabilities)
- Within the last year, youth has been involved with and transitioned from at least one of the below services,
  OR is currently in one of the below services and is transitioning back in the next 30 days:
  - Out-of-home care and treatment (state psychiatric center, psychiatric inpatient hospital, OMH RTF, OMH Community Residence, residential SUD treatment, juvenile justice residential placement, OCFS RTC, etc.)
  - Intensive care/treatment for SED (partial hospitalization, children's day treatment, Youth ACT, HCBS Waiver with K3 code)
  - Two or more crisis responses due to mental health challenges (ER visit, mobile crisis response, emergency respite / Children's Crisis Respite)
  - Intensive crisis intervention: Home-Based Crisis Intervention (HBCI) and/or Mobile Integration
    Team (MIT)
  - Foster care
  - Youth is currently going through application process or on the waitlist for Youth ACT or Out-of-home care and treatment, or has been found eligible for RTF level of care
