Kids' Adventure Club utilizes Birnie Transportation for all outsourced transportation needs. Kids' Adventure Club and Birnie Transportation are in compliance with all regulations relating to driving credentials and background checks.

Kids' Adventure Club follows the Corning-Painted Post School District and Birnie Transportation policies and procedures for travel; this includes seatbelt use only with parent permission, bus safety rules and emergency procedures.

Specific transportation routes including travel time will be provided with permission slips. Kids' Adventure Club staff will be present and seated throughout the bus to provide competent supervision. Attendance will occur when boarding and disembarking from the bus.

Kids' Adventure Club staff will carry emergency contact information for all children on the bus. If a child becomes ill or unable to participate in the field trip activity a parent or emergency contact may be requested to pick up at the field trip location.

When construction prohibits Kids' Adventure Club from being at their home school, as a courtesy the Corning Painted Post School District will provide transportation. All policies, procedures and disciplinary action for student conduct is dictated by the school district's policies and procedure. The Kids' Adventure Club Transportation Plan does not apply under these circumstances.
